SCITUATE FEDERAL SAVINGS BANK YOUNG MASTERS SCHOLARSHIPS

North River Arts Society is pleased to announce that Scituate Federal Savings Bank has pledged \$300 annually to support two new scholarships (\$150 each) for students to apply toward the registration in our Summer Young Artist Masters Program.

PURPOSE:

These scholarships are intended to encourage local students ages 12-18 to further their interest in art.

REQUIREMENTS:

The North River Arts Society encourages students age 12-18 who are interested in art, have taken art classes (public or private), have created artwork outside of classes, and may plan to pursue their interest of art by applying to a school of fine arts, or an institute of higher learning which includes fine arts in its curriculum.

Students interested in applying for this scholarship should contact the NRAS office via email, telephone or in person to obtain an application. Along with the application, students will be required to submit at least one sample of their artwork (up to three pieces may be submitted). This artwork may be the result of a class assignment or a piece that the student has created outside of a classroom. Artwork may be submitted via slides or digitally on a CD.

Applications will be accepted up to two weeks before the start-date of the first Young Artist Masters class of the current summer season. Students will be notified at this time if chosen as recipient of the scholarship.

Each student is only eligible for one scholarship per summer.

Students may be recommended for this scholarship by an art instructor – either from a public or private education facility, however, this is not a requirement – students may apply on their own.

Specific Young Artist Masters programs vary each summer and will be listed on the website as they are confirmed. NRAS typically offers at least 4 programs for this age group. All courses depend on having at least 5 students enrolled.
