The **34th Annual Festival of the Arts** is now being planned. The North River Arts Society is accepting applications from artisans who would like to participate in this year's Juried Artisans Exhibit and Sale.

This exhibit is one of many features of this two-day event. Over 200 artists take part in other exhibits including Art & Sculpture, Photography, and the Festival Art Sale (sale prices). There is live entertainment scheduled throughout the weekend, a childrens' tent with many activities, and a food tent for refreshments.

Once again, we are anticipating a gala festival this year and expect to attract well over 6,000 visitors. The festival is held on Memorial Day weekend, Saturday, May 29 and Sunday, May 30 from 10:00 a.m.-5:00 p.m. each day.

If you are a past exhibitor, thank you for participating in this springtime event, which so many people look forward to. Please plan to apply again this year.

If you have not exhibited in this show previously, we hope you will consider applying this year to be a part of the festivities.

### DATES TO REMEMBER

**March 12, 2010** Application Deadline. **Two (2) checks** sent with application - \$20. application fee and \$100. members/\$150. nonmembers site fee.

**April 9, 2010** Notification letters sent to artisans. Accepted artisans will receive site location at this time. Those not accepted this year will have site fee checks returned. Credit card site fees will not be charged until this time.

**May 28, 2010** Early set-up available after 5:00 p.m. Gala Opening Reception begins at 7:00 p.m. G.A.R. Hall. Check website for details.

### ELIGIBILITY

**All work offered for exhibit and sale must be designed and created by the applicant.** Agent/Dealers are not accepted. No imports, finished products from commercial molds, or crafts done from commercial kits will be accepted. We make this ruling in order to maintain the quality for which this show has become known. We reserve the right to decline space to anyone exhibiting inappropriate items. **If you want to share your space with another artisan, they must apply and be juried in as well.** Please see application form.

Any work that is juried into the Juried Art & Sculpture or Photography Exhibit is not eligible to be sold in the Juried Artisans Exhibit.

### FACILITIES

This show is held **outdoors**, rain or shine. Each space is 10 feet by 12 feet. Artisans must supply their own tables, chairs, and tents or canopies, if desired. Displays may be left overnight if secured under a tent. **NRAS is not responsible for loss or damage.** There is a parking area available. Coffee and donuts will be served Saturday and Sunday mornings.

### REGISTRATION

1. Complete the application form enclosed.
2. Submit 6 slides, photos, or digital images on a disc of your work plus **one image depicting your booth display.**  
*As the invited jurors are different every year, it is very important that you submit all requested materials.*
3. **Two checks:** nonrefundable application fee: **\$20.** Site fee: **\$100.** NRAS members/**\$150.** non-members. Payment by check (NRAS) Visa or Mastercard.
5. Include a *stamped, self-addressed envelope* for slides, discs or photos to be returned with the notification letter.
6. Applications must be received by **March 12, 2010.**

Right on Pine - to end (church on right)  
Left on Rte. 3A - follow to lights.

Right on Highland - straight thru small inter-  
section onto Pleasant. Artisans area is on left,  
next to a large white house.
